**BIESSE: RESULTS FOR THE SECOND QUARTER 2002 APPROVED**

Pesaro, 09 August 2002 – Today, the Board of Directors of Biesse S.p.A. has approved the quarterly report as of 30 June 2002. Biesse is an Italian company with headquarters in Pesaro. It is quoted on the Star segment of the Italian stock exchange, and is one of the world's most important operators on the market of machines and systems for the processing of wood, glass and marble.

The turnover and the profitability show a clear recovery compared to the first quarter of 2002, with a turnover that increased by 28,5%, a gross operating spread of 6.8 million euros (in the first quarter it was negative by 2.4 million euros) and an operating result of 4.0 million euros (in the first quarter it was negative by 5.5 million euros).

"In the second quarter, the income indicators show a clear recovery compared to the first three months of this year", so the General Manager, Mr. Claudio Granuzzo, points out. "On the one hand they highlight the first encouraging signs of market recovery, on the other hand they underline the important work that has been done by the Biesse Group with regard to rationalisation of structure and business processes".

In the second quarter of 2002 (April-June), consolidated revenues amounted to 90.6 million euros, a 10.0% decrease compared to the second quarter of 2001.

The consolidated gross operating spread was positive by 6.8 million euros, while in the same period of the previous business year it amounted to 10.6 million euros.

The consolidated operating result in the same period (from April to June 2002) was positive by 4.0 million euros, while in the same period of the

Net indebtedness as of 30 June 2002 amounted to 103.8 million euros: a slight improvement compared to the previous quarter when it was 106.7 million euros.

Thus, in the first half of 2002, consolidated revenues amounted to 161.1 million euros: a decrease of 8.2% compared with the first six months of 2001.

The gross operating spread amounts to 4.4 million euros (15.0 million euros in the first six months of 2001), while the consolidated operating result is negative by 1.4 million euros (compared to the operating result of the first half of 2001 that resulted positive by 9.5 million euros).

In that respect, it remains to be mentioned that the first half-year of 2001 did not yet suffer the slackening in market activity that only started with the third quarter of 2001, and the negative influence of which was still perceptible during the entire first six months and – although to a lesser extent – even in the second quarter of 2002.
